For smaller entities who don't typically use a reverse distributor, the TakeAway Medication Recovery System for DEA Reverse Distribution for Registrants is a convenient, environmentally-safe option. It is a DEA-compliant collection, return and destruction solution for DEA registrants' expired or unused controlled substances (Schedules II-V).

All orders must be placed with DEA registrant's registration number. The customer must complete DEA Controlled Substances for Destruction Form, and then Sharps will release the order, and ships the customer a system, including a return UPS label. Additional forms may be required if Schedule II's are included in the inventory. No hazardous pharmaceuticals or biohazardous materials are allowed. Once the pail is full, the customer packages and ships it to Sharps' DEA-approved reverse distribution location for safe and compliant treatment.
