## **1. Introduction & Objective**

Sharps Compliance, Inc., (Sharps or the Company), is seeking a New York State Part 360 Solid Waste Management Permit from the New York State Department of Environmental Conservation (NYSDEC) to own and operate a Regulated Medical Waste (RMW) Transfer Facility located at 893 Shepherd Avenue in Brooklyn, NY.

This Public Participation Plan (PPP) has been prepared by Sharps as part of its permit application. Commissioner Policy-29, Environmental Justice and Permitting (CP-29), requires permit applicants for certain facilities to develop and execute a public participation plan to ensure that potentially impacted communities receive timely and useful information about the proposed facility and opportunities to participate in the permit application process.

## **2. Project Description & Proposed Actions**

Sharps proposes to own and operate a fully enclosed RMW transfer facility in an existing building in an area zoned for industrial uses. The facility would receive, store and transfer for offsite treatment sealed containers of RMW collected from area healthcare facilities such as physician, dentist, and veterinary offices, retail pharmacies offering immunization services, home health care providers, and assisted living facilities.

The existing building at 893 Shepherd Avenue, Brooklyn, NY 11208 is approximately 22,000 sq. ft. and located in an industrial area with an M1-1 zoning designation (see Figure 1). The fully enclosed building is currently used as a base for Sharps' existing RMW collection business (operated by Sharps' subsidiary Citiwaste LLC), with administrative offices and indoor parking for collection vehicles (box trucks) and employee vehicles. As a transfer station, the building would continue to house administrative offices and parking for collection and personal vehicles, and would also have receiving, loading and unloading areas, and temporary RMW container storage areas. Throughout the collection and consolidation process (from healthcare facility to offsite treatment), RMW containers would remain sealed. Operations would be carried out in accordance with all local, state and federal laws. The proposed facility would be open 6:00 am to 7:00 pm Monday through Friday and closed holidays. At peak operations the facility would receive RMW from 30 collection vehicles per day and consolidate that material into a maximum of 7 long-haul trucks per day for shipment to off-site treatment facilities.

#### **4. Stakeholders and Outreach Contact List**

In consultation with NYSDEC staff, Sharps has assembled a list of stakeholders who may be interested in and affected by the proposed project and are therefore targeted for outreach. This list, provided in Appendix A, includes local elected/government officials; community, civic, religious and environmental organizations; local media outlets, and residents, businesses and property owners located within a 500-ft radius of the proposed facility. #### **5. Public Outreach Activities**

In order to inform the public about the proposed facility in accordance with Commissioner Policy-29, several outreach activities are being planned and conducted. These include reaching out to community leaders for individual briefings, planning and holding a public information meeting near the proposed facility, preparing and distributing to all stakeholders a notice regarding the public information meeting, and preparing and disseminating a fact sheet about the project. Each activity is described in more detail below.

### 5.1 Informational Briefings

Sharps sent letters to local government and elected officials notifying them of the pending application and offering to provide them with in-person briefings. To date, five officials have met with Sharps representatives and received in-person briefings – Borough President Eric Adams, State Senator Roxanne Persaud, NYC Council Member Inez Barron, State Assemblymember Charles Barron, and Community Board 5 District Manager Melinda Perkins. Sharps provided information regarding the location and operations of the proposed facility, answered questions, and solicited feedback on further outreach and potential concerns. Sharps will continue to extend invitations to other local elected and government officials for one-on-one briefings.

### 5.2 Public Information Meeting

Sharps will hold a Public Information Meeting at P.S. 202, Ernest Jenkyns School located at 982 Hegeman Ave, Brooklyn, NY 11208 on September 17, 2018, 7:00 p.m., to provide interested members of the community with information about the proposed action. Sharps will present information on the location and layout of the proposed facility, the material that would be accepted and transferred at the facility, the procedures for receiving, storing and transferring RMW, and steps that would be taken to minimize any potential impacts. The presentation will include illustrative maps, figures and photographs. Sharps will also distribute a fact sheet in both English and Spanish and inform attendees how they may submit comments on the application for consideration by NYSDEC. The applicant and its representatives will also provide an opportunity for the public to ask questions and offer comments.

### 5.3 Public Notice

Sharps has prepared a public notice in English and Spanish inviting the public to attend the Public Information Meeting to be held at P.S. 202, Ernest Jenkyns School located at 982 Hegeman Ave, Brooklyn, NY 11208 on September 17, 2018 from 7:00 p.m. to 10:00 p.m. (Public Notice). See Appendix B. The Public Notice will be sent to all stakeholders by first class mail on or about August 20, 2018, and no later than August 27, 2018.

## Fact Sheet

Sharps Compliance, Inc., (Sharps) seeks a NYS Department of Environmental Conservation (DEC) Solid Waste Management permit to operate a regulated medical waste transfer facility at 893 Shepherd Avenue, Brooklyn, New York. Application ID# 2-6105-00889/00001. Pursuant to NYSDEC Commissioner Policy 29, Environmental Justice and Permitting (CP-29), a Public Participation Plan and this fact sheet has been prepared in order to inform the public about the project and provide the opportunity to comment during the permit application review process.

**The Proposed Facility:** Sharps proposes to use an existing 22,000 square foot building at 893 Shepherd Avenue, Brooklyn, NY which currently serves as a base of operations for Sharps' regulated medical waste ("RMW") collection business, as a transfer facility where sealed containers of RMW collected by Sharps' fully permitted collection vehicles (box trucks) could be consolidated into long-haul trucks for shipment to out-of-state treatment facilities. At the transfer facility, trained workers will receive, inspect, weigh and temporarily store sealed containers of RMW, and then load them onto long-haul trucks. All containers would remain sealed at all times and all loading and unloading of vehicles would take place inside the enclosed building. RMW containers may be stored unrefrigerated for up to 72 hours after receipt. Containers stored longer than 72 hours will be refrigerated. The facility would handle at a maximum, 48 tons of RMW per day. The proposed facility would operate 6 AM to 7 PM Monday through Friday, closed holidays.

**What is RMW?** RMW is waste generated in the diagnosis and treatment of people or animals in doctors' offices, nursing homes, veterinary clinics, pharmacies and similar kinds of medical or research facilities. It includes, for example, used bandages, discarded surgical gloves, IV tubing, needles and gowns. The collection, transportation and ultimate disposal of medical waste is highly regulated to protect health care workers, transporters and members of the public.

**Why does Sharps need the Transfer Station?** Sharps, through its subsidiary Citiwaste, already collects RMW from local healthcare facilities, prepackaged in leakproof containers compliant with federal regulations. There are currently few options for transferring RMW near most of Sharps' collection routes. By combining collections and transfer in one facility, Sharps will reduce the miles the collection fleet must travel to transfer its sealed containers. The transfer station would generate, at most, 30 collection vehicle trips and 7 long-haul truck trips to and from the facility per day.

**How might the proposed transfer station impact the surrounding community?** Sharps is aware that certain environmental impacts including truck traffic, noise, and air pollution may be of concern. Sharps intends to incorporate measures into its operations that eliminate or mitigate these potential impacts such as, but not limited to, all operations will occur inside the fully enclosed facility behind closed doors, no queuing on public streets, and vehicle loading and unloading will occur within the facility. Also, RMW is subject to specific handling and disposal regulations, and compliance with these requirements generally eliminates possible significant adverse impacts.

**How can I participate in the permit review process?** You may provide comments to be considered in the permit review process, including comments on the development of mitigation measures, operations, impacts to the community and the draft permit. Comments may be given at the public meeting(s) and in writing to the DEC during the public comment period. ## Fact Sheet

Sharps Compliance, Inc., (Sharps) busca un permiso de Manejo de Desechos Sólidos del Departamento de Conservación Ambiental (DEC) del Estado de Nueva York para operar una instalación regulada de transferencia de desechos médicos en 893 Shepherd Avenue, Brooklyn, Nueva York. ID de aplicación n.º 2-6105-00889 / 00001. De conformidad con la Política 29 del Comisionado NYSDEC, Justicia ambiental y permisos (CP-29), se preparó un Plan de participación pública y esta hoja informativa para informar al público sobre el proyecto y brindar la oportunidad de comentar durante el proceso de revisión de solicitud de permiso.

**El servicio propuesto:** Sharps propone usar un edificio existente de 22,000 pies cuadrados en 893 Shepherd Avenue, Brooklyn, NY que actualmente sirve como base de operaciones para el negocio de recolección de desechos médicos regulados de Sharps ("RMW"), como una instalación de transferencia donde se recolectan contenedores sellados de RMW por los vehículos de recolección permitidos, completamente, (camiones de caja) de Sharps podrían consolidarse en camiones de largo recorrido para su envío a instalaciones de tratamiento fuera del estado. En la instalación de transferencia, los trabajadores capacitados recibirán, inspeccionarán, pesarán y almacenarán temporalmente contenedores sellados de RMW, y luego los cargarán en camiones de largo recorrido. Todos los contenedores permanecerían sellados en todo momento y toda la carga y descarga de los vehículos se llevaría a cabo dentro del edificio cerrado. Los contenedores de RMW pueden almacenarse sin refrigeración durante hasta 72 horas después de la recepción. Los contenedores almacenados por más de 72 horas serán refrigerados. La instalación manejaría un máximo de 48 toneladas de RMW por día. La instalación propuesta funcionaría de 6 AM a 7 PM de lunes a viernes, feriados cerrados.

**¿Qué es RMW?** RMW es un residuo generado en el diagnóstico y tratamiento de personas o animales en consultorios médicos, hogares de ancianos, clínicas veterinarias, farmacias y centros médicos o de investigación similares. Incluye, por ejemplo, vendajes usados, guantes quirúrgicos desechados, tubos IV, agujas y batas. La recolección, el transporte y la eliminación definitiva de desechos médicos están altamente regulados para proteger a los trabajadores de la salud, a los transportistas y al público en general.

**¿Por qué Sharps necesita la estación de transferencia?** Sharps, a través de su filial Citiwaste, ya recolecta RMW de las instalaciones locales de salud, preempacado en contenedores a prueba de fugas que cumplen con las regulaciones federales. Actualmente hay pocas opciones para transferir RMW cerca de la mayoría de las rutas de recolección de Sharps. Al combinar colecciones y transferencias en una instalación, Sharps reducirá las millas que debe recorrer la flota de recolección para transferir sus contenedores sellados. La estación de transferencia generaría, a lo sumo, 30 viajes de vehículos de recolección y 7 viajes de largo recorrido hacia y desde la instalación por día.

**¿Cómo podría afectar la estación de transferencia propuesta a la comunidad circundante?** Sharps es consciente de que ciertos impactos ambientales, incluido el tráfico de camiones, el ruido y la contaminación del aire pueden ser motivo de preocupación. Sharps intenta incorporar medidas en sus operaciones que eliminen o mitiguen estos impactos potenciales, tales como, entre otras, que todas las operaciones se lleven a cabo dentro de las instalaciones totalmente cerradas a puertas cerradas, sin cola en las calles públicas y la carga y descarga de vehículos se realizará dentro la instalación. Además, RMW está sujeto a regulaciones específicas de manejo y eliminación, y el cumplimiento de estos requisitos generalmente elimina posibles impactos adversos significativos.

**¿Cómo puedo participar en el proceso de revisión de permisos?** Puede proporcionar comentarios para ser considerados en el proceso de revisión de permisos, incluidos los comentarios sobre el desarrollo de medidas de mitigación, operaciones, impactos a la comunidad y el borrador del permiso. Los comentarios se pueden dar en la (s) reunión (es) pública (s) y por escrito al DEC durante el período de comentario público.
